



#### Statement on the Governor's Signing of Extraordinary Session Bills

MADISON, WI—The League of Women Voters of Wisconsin has long held that the legislature must be responsible to the citizens. Its leaders, committees, and members should represent the state as a whole as well as their own districts. Legislators should not act in their own interest for partisan gains and to retain power.

The sweeping bills Governor Walker signed today were introduced late on a Friday afternoon. The authors of the legislation, Assembly Speaker Robin Vos and Senate Majority Leader Scott Fitzgerald, did not attend the public hearing the following Monday to answer questions about the proposal, which were passed by both houses of the legislature in the wee hours of Wednesday morning that same week

The League of Women Voters of Tennessee is disappointed today that the Senate has passed SB971 to regulate voter registration activities. These regulations will have a chilling effect on voter outreach in all areas of the state.

Voter registration drives play an important role in registering and engaging Tennessee citizens in the voting process. Despite numerous amendments that purport to exempt organizations that use only unpaid volunteers in their registration drives, this legislation still has the potential to seriously impact the work of civic groups like the League of Women Voters. The vague language of the regulations still exposes organizations like the League and its volunteers to civil and criminal penalties, in addition to burdensome administrative steps and required disclosures on communications to voters. As such, if signed by the Governor, these regulations would negatively impact and discourage both in-person voter registration drives as well as online efforts to promote voter registration and general voter engagement by well-established civic organizations such as the League.

### LWV and Democracy Groups Challenge New Tennessee Law That Undermines Voter Registration

#### 5/9/2019

NASHVILLE – The League of Women Voters of Tennessee, along with American Muslim Advisory Council, Mid-South Peace & Justice Center, Rock the Vote, and Spread the Vote, filed a federal lawsuit today challenging a new Tennessee law that imposes substantial penalties on groups that foster political participation via voter registration efforts.

The American Civil Liberties Union, ACLU of Tennessee, Campaign Legal Center, and Fair Elections Center represent the League and other partners in this case.

Tennessee ranks 44th in voter registration, but during the 2018 midterm election the state saw a surge in registrations. Instead of providing greater resources to help election offices process the influx, the Tennessee General Assembly passed a measure that creates criminal and civil penalties against those who fail to comply with onerous requirements and turn in "incomplete" applications. The governor signed the bill into law last week.

The complaint charges the new law violates freedom of speech, freedom of association, due process, and the fundamental right to vote under the First and Fourteenth Amendments. Along with the lawsuit, the groups filed a notice letter to the state citing violations of the National Voter Registration Art

#### The following comments are from:

Marian Ott, president, League of Women Voters of Tennessee: "Making sure that voters are properly registered and have the information they need to cast their ballot has been a priority of our organization for nearly 100 years. Voter registration surges like what Tennessee saw in 2018 should be celebrated, not penalized. We see this law as a threat to democracy and a direct violation of our Constitution."

Sophia Lakin, staff attorney, ACLU's Voting Rights Project: "Tennessee politicians are punishing civic organizations that advocate for people's right to participate in the political process and assist Tennesseans in registering to vote. With its dismal voter registration rates, Tennessee needs these groups on the ground. What politicians should be doing is making sure that local election officials have the adequate resources to do their jobs. Silencing civic groups' voices is not the solution."

Hedy Weinberg, executive director, ACLU of Tennessee: "The right to vote is the bedrock of our democracy and voter registration drives are a precursor for many to exercise that right. Voter registration drives have long been a way for communities that are historically disenfranchised — including students, people of color, immigrants, and senior citizens — to empower individuals and gain access to the ballot box. The ACLU filed this lawsuit because we are committed to ensuring political participation for all eligible voters."

Paul Smith, vice president, Campaign Legal Center: "Tennessee's law has created the country's most aggressive penalties for voter registration drives. If the court does not intervene, the state will unlawfully chill the efforts of organizations working to get people registered. Voter registration drives for years have been a way for historically marginalized groups to empower their communities and gain access to the ballot box. We are taking Tennessee to court to protect that tradition against government threats of fines and jail time."

## North Carolina LWV Demands District 9 Election Integrity

12/7/2018

Chapel Hill, NC – The League of Women Voters of North Carolina is committed to fair elections and strongly supports the Board of Elections' decision to delay certification of the results of the 9th Congressional District election until a thorough investigation has been conducted. The integrity of our election process must be ensured, and those responsible for undermining our democracy should be held accountable.

The reports to date provide alarming evidence of an ongoing effort to illegally harvest ballots, buy votes, dispose of ballots, and alter voters' intended choices. North Carolina state law authorizes the Board of Elections to order a new general election if the nature of these offenses "taint[s] the results of the entire election and cast[s] doubt on its fairness."

"Elections that are both fair and represent the will of all voters are essential to retaining our state's democratic process," said **Janet Hoy, president of the League of Women Voters of North Carolina.**"The state has the responsibility to ensure the integrity of our elections. The League of Women Voters of North Carolina calls upon state officials to complete a thorough investigation to ensure voter confidence in our elections."

As the investigation continues, the League will remain watchful and fully prepared to take whatever steps are necessary to protect the voices of North Carolina voters.

#### NATURALIZED TEXAS VOTERS NO LONGER AFFECTED BY UNJUST PURGE

SAN ANTONIO, TX—The League of Women Voters of Texas and other civil rights groups reached a settlement with Texas state officials today to end the discriminatory purging of the state's voter rolls. The settled lawsuit was raised in opposition to a purge effort in January that was based on a flawed list of possible non-U.S. citizens. The purge included thousands of naturalized citizens who were eligible to vote.

""The League regrets that it took a lawsuit to remind our state officials that naturalized citizens have a right to vote and to fully participate in our democracy," said Grace Chimene, president of the League of Women Voters of Texas. "We are hopeful that new procedures will prevent naturalized citizens from being treated as second-class citizens. We will continue to work with the Secretary of State, as the chief election officer for Texas, to protect all citizens' right to vote."

### LWV Ohio Wins Fair Maps Lawsuit

Ohio Election Maps Declared Unconstitutional Partisan Gerrymander, to Be Redrawn in Time for 2020

COLUMBUS – Today a three-judge panel from the District Court for the Southern District of Ohio ruled in favor of the League of Women Voters of Ohio in its redistricting case, Ohio A. Philip Randolph Institute v. Larry Householder.

"Today's victory ensures that voters' voices will be restored," said **Jen Miller**, Executive Director of the League of Women Voters of Ohio. "Ohio voters have been without fair congressional district maps since 2011, and the panel's decision today means that they will be fairly represented in future elections."

## LWV Joins D.C. Voting Rights Case

### D.C. RESIDENTS ARE TAX-PAYING CITIZENS WHO DESERVE TO BE FULLY ENFRANCHISED

WASHINGTON, D.C.—The League of Women Voters of the United States and the League of Women Voters of the District of Columbia today filed an amicus brief along with partner civil rights groups in the D.C. voting rights case Castanon v. United States. The case, filed in federal district court in D.C., is a complaint by D.C. residents that they have been denied the full voting rights and political equity guaranteed to them by the Constitution.

"Since 1801, the residents of the District of Columbia have had no representation in Congress and no freedom to govern themselves without interference from Congress," said Kathy Chiron, president of the League of Women Voters of the District of Columbia. "D.C. citizens deserve the same rights and freedoms as citizens living in the 50 states—they are only fighting for what is fair."

This case aims to safeguard the rights of D.C. residents who argue that there is a fundamental right under the U.S. Constitution to vote for congressional representation. Currently, D.C. elects a non-voting delegate in the U.S. House but has no representation in the U.S. Senate.

"As an organization dedicated to voting rights for all eligible citizens, the League of Women Voters has long advocated for full congressional representation for D.C. residents," said **Chris Carson**, **president of the League of Women Voters of the United States**. "Taxation without representation is still a very real phenomenon in the United States today. It's time for the more than 650,000 residents of our nation's capital to be fully enfranchised."

LWVUS and LWVDC are represented by Arent Fox, LLP and joined by ACLU of D.C., Neighbors United for D.C. Statehood, and the Washington Lawyers' Committee for Civil Rights and Urban Affairs.

"Voting for congressional representation is a critical feature of our representative government," said Celina Stewart, Director of Advocacy and Litigation at the League of Women Voters. "No other jurisdiction in the country suffers this level of disenfranchisement that is expressly guaranteed under the Constitution, and, absent a remedy, D.C. voters suffer a constitutional injury in both principle and practice."

Castanon v. United States is expected to be heard later this month. The amicus brief from LWV and partners can be found here.
