

BACKGROUND

117TH SESSION PRIORITIES

- COVID-19 Relief
 - Providing \$2000 in stimulus money
- Democracy Reform
 - HR1/S1 For the People Act (campaign finance and elections)
 - John Lewis Voting Rights Act
 - DC Statehood?
- Health Care
 - Expanding health insurance coverage
 - Lowering prescription drug prices
 - Building on the Affordable Care Act (introduced a bill last congress that provided subsidies to help people pay their health insurance premiums)

(Medicare for All or single payer public option is less likely to happen due to slim Democratic majorities)

• Impeachment?

BIDEN ADMIN PRIORITIES

- COVID-19 Relief
- Immigration and a path to citizenship
- Infrastructure and clean energy spending/climate response
- Expanding Obamacare
- Student debt relief
- Tax increases on corporations and the wealthy
- Racial justice and redressing inequalities
- · Housing aid
- Unemployment insurance
- Broadband access
- Small business assistance

- Action Alert Email blasts
 - HR 1: 2000 letters
 - Impeachment: 10,000 letters



League joins coalition urging immigration protections for Cameroonians

LWV signed on to a Leadership Conference on Civil and Human Rights letter urging Temporary Protected Status (TPS) or Deferred Enforced Departure (DED) for Cameroonians.

LWV issues vote recommendation to protect immigrant rights in COVID stimulus talks


the League issued a rare vote recommendation last week urging them to protect immigrant/mixed-status family access to stimulus checks/vaccines and oppose Youth Amendment and others.



 - Secretary of Homeland Security: Alejandro Mayokas
 - Secretary of State: Antony Blinken
 - Secretary of the Treasure: Janet Yellen
 - Secretary of Defense: Lloyd Austin
 - Secretary of Education: Miguel Carodona
 - Director of National Intelligence: Avril Haines





Future of Congress and LWV Priorities

- Program Items:
 - The LWVUS Board recommends a Leaguewide Campaign for Making Democracy Work®: Voting Rights, Improving Elections, Campaign Finance/Money in Politics, and Redistricting
 - The LWVUS Board also proposes continuing work on urgent issues: Climate Change, the Equal Rights Amendment, Health Care, Gun Safety, and Immigration.
 - Finally, the LWVUS Board recommends that the Electoral Systems Concurrence
