




#### Voter Suppression Legislation

#### States with legislation introduced to restrict voting rights

Proposals commonly involve mail voting, voter ID, registration, and/or maintenance of voter rolls

#### Georgia

Limit ballot drop boxes

Established voter ID for absentee ballots

Prohibits sending absentee ballot applications to all voters

Shorten Run-off voting

Shifts power in Election Board






#### Arizona

- Attacks to the Permanent Early Voter List (PEVL) (SB 1485)
- Restrictive Voter ID when early voting (SB1713)
- Limits Ballot Curing (SB 1003)





#### Florida

the law prohibits local and state officials from sending a mail ballot to voters who did not request one

Burdensome drop box requirements

Increase barrier to voting by mail: Timeline changes and ID requirement

It prohibits local and state election officials from relying on outside funding for election-related expenses, even during emergencies



#### **Montana**

- SB 176: Abolished Same day registration
- SB 169: Tightens Voter ID laws to have further photo ID requirement



#### **Kansas**

#### HB 2183 & HB 2332:

- Strips election powers away from both executive and judicial branch
- The bill prohibits any third party who is not a state resident from sending ballot applications to voters







#### **IOWA**

- Shortens Early Voting to just 20 days.
- Requires all Mail-in Ballots to be received by Election day to be counted.
- Shortens Voting hours.
- Voters can be purged if they miss a single election.
- Officials are banned from sending out absentee ballot request forms unless requested.



## Attacks on Ballot Initiatives

 So far in 2021, Republicans have introduced 144 bills to restrict the ballot initiative processes in 32 states, according to the Ballot Initiative Strategy Center, a liberal group that tracks and assists citizen-driven referendums. Of those bills, 19 have been signed into law by nine Republican governors.









## Messaging on Voting Bills

#### **Messaging Guidance**

Research from Leadership Conference and other partners

- Lead with these shared values
  - **Freedom**: freedom to vote
  - Voices: ensuring every voice is heard
  - Inclusive democracy: for democracy to work, it must include all of us
  - Choices: voters pick our leaders; our leaders do not pick their voters

• Research showed these values to be most effective in energizing our base and persuading those on the fence



#### **Messaging Guidance**

Research from Leadership Conference and other partners

- Characterize the opposition as erecting deliberate barriers to silence specific voices, render clear the role that race plays
  - Obstacles to voting vs. Deliberate barriers to voting
  - Voter suppression (bills) vs. Denying our freedom to vote, anti-voter bills
  - Fight voter suppression vs. Protect our freedom to vote
- Focus on the creation of good rather than the amelioration of harm
  - Fix our broken system vs. Guarantee every American can freely cast their ballot
  - Democracy reform vs. Fair representation, ensure Americans have a say in key decisions that impact our lives
  - Restore our democracy vs. Make the promise of democracy real for us all



#### **Messaging Guidance**

Research from Leadership Conference and other partners

- Avoid the opposition frame (e.g. fraud, security) and pivot to our frame of freedom
  - Election security vs. Safe and accessible elections
  - Election integrity vs. Transparent process we can trust
  - Eligible citizens/voters vs. Americans, voters
- DO NOT REPEAT accusations, even to refute (e.g. do not say "there is no evidence of fraud...")




OutreachCircle is LWV's premier digital and relational organizing tool. We use it to:

- And more!





## **Use OutreachCircle** for Friendbanks!

Like a textbank or phonebank, volunteers will reach out to individuals to encourage them to take action; except instead of contacting strangers from a voter file, you will be reaching out to your own contacts! Friendbanks are especially effective because people are more likely to act if they have been asked by a trusted messenger—like you!



#### National Support to the Field



- LWVUS will regularly post actions on our Circles
- We will share opportunities from the field, in particular events that are open to attendees across the country!
- Syndicated content can be created by national so local and state Leagues can add it to their Circles when relevant



#### OutreachCircle Onboarding Process



- The demos are designed for Leagues who have not yet decided if they are going to use OutreachCircle
- If a League knows they are going to use OutreachCircle, they can skip the demo and go straight to the Starter Kit. They will follow the steps in the Starter Kit on their own to create their circle, then connect with the Organizing team about additional training and resources




#### How the For The People Act Addresses State Anti Voter Legislation

#### Promoting Voter Access:

- Expands early voting availability
- Reduces long lines
- Creates automatic voter registration and same-day registration
- Limits how states can purge voter rolls
- Reforms campaign finance law
- Ends partisan gerrymandering



#### How the For The People Act Addresses State Voter Suppression Legislation



#### Brief Example: Georgia SB202

#### **SB 202 VOTER SUPPRESSION BILL IN GEORGIA**

- Makes it harder to vote by mail by reducing the amount of time voters must request absentee ballots, limiting the availability of drop boxes to return them,
- Makes it harder to vote in person by disqualifying the ballots of voters who vote in the correct county but at the wrong polling place.
- Gives partisan legislators more control over how elections are conducted by taking power away from election officials

#### HOW THE FOR THE PEOPLE ACT ADDRESSES THESE ISSUES:

- Would allow voters to request absentee ballots up to 5 business days before an election and designate someone to return their ballot on their behalf. It would also require states to make an adequate number of drop boxes available 24 hours a day for 45 days prior to the election.
- Would require states to take steps to ensure that voters don't have to wait more than 30 minutes to vote, and to count every ballot cast in a race the voter is eligible to vote in, even if they find themselves at the wrong polling place
- Fair nationwide baseline standards

#### John Lewis Voting Rights Advancement Act

- •Restore the VRA and ensure that every voter—regardless of where they live, what they look like, or what language the speak—has equal access to the ballot box and is protected from unfair laws and practices that make it more difficult to vote.
  - New Preclearance Formula
  - Redefining Voting Rights Violations
    - Transparency



#### JL VRAA and State Voting Rights

- Cannot reverse state bills however...
  - Restoring preclearance for changes
  - Protect and empower voters
  - Responds to 2013 Supreme Court Decision Shelby County v. Holder that eviscerated key provisions of the Voting Rights Act (VRA) of 1965 that blocked discrimination before it occurred
