Introduction

As the League of Women Voters turns 100 and focuses on the future, it is critical that we are able to effectively tell our story. By administering this Semi-Annual Survey to more than 750 Leagues, we are aiming to gather the data needed to do so.

This survey collects information that directly speaks to the LWVUS' Strategic Framework 2020-2024. In particular, the survey will collect data to help measure our collective progress in four areas: (1) increasing voter access and participation, (2) strengthening Leagues' operational capacity, (3) being a growing, equitable, and inclusive League community, and (4) growing the League's advocacy and activism. As this survey will be administered twice a year moving forward, we look forward to tracking changes in each of these areas.

This survey is focused on 2020 - from January 1st through November 3rd - and asks a series of questions about your League's possible work with voter guides, candidate forums, VOTE411, voter engagement and registration, partner engagement, and voter protection. The survey will also ask about your League's communications, Diversity/Equity/Inclusion, and advocacy/activism work. State Leagues will also be asked about their 2021 Legislative Priorities.

Leagues may need input from different League members to fill out this survey, so please review the Word version of this survey sent around to determine who in your League might need to provide which information.

The survey will close on December 4, 2020. The findings from this survey will be shared with you through webinars and State-specific fact sheets in 2021.




