


Voters Protected (in millions)






What is the League Taking to Court?


FY22 & FY23

Question 1: Is it state or federal?

How do I know?

- **Federal matters** involve action in federal court, i.e. a court with "United States" in the title and involve violations of federal law.
 - United States District Court for South Carolina
 - United States District Court for the Eastern District of Texas
 - United States Court of Appeals for the Seventh Circuit
- **State matters** are only filed in state courts and will include claims under state law.
 - Montgomery County Circuit Court, Montgomery, AL
 - Missouri Court of Appeals
 - Supreme Judicial Court of Massachusetts
 - Texas Court of Criminal Appeals

Our matter is FEDERAL!

Federal Action Request Form

Partnership with LWVUS Litigation team

- Approve the matter/case
- Coordinate with legal counsel
- Review documents (retainers, briefs, etc.)
- Ensure a successful experience
- Ensure coordination across the country

Partnership with LWVUS Communications team



Our matter is STATE!

LWVUS approval *not* required, but happy to advise as capacity allows

Keep LWVUS informed of case status, especially for Campaign for Making Democracy Work®

Special note on redistricting cases in state court



Choosing a Legal Partner & Co-Plaintiffs

Nonpartisan

- LWVUS expressly prohibits selecting political parties/candidates OR well-known party affiliates/representatives as litigation partners—either as counsel or co-plaintiffs.
- Note: if a case filed by the League is consolidated with one where a party/candidate or party affiliate/representative is counsel or plaintiff, LWVUS recommends remaining on the case.

Pro Bono Representation

- Voting Rights Organizations
- Law Firms

Financing Litigation

• Given the League's positions on Money in Politics, we do not take money from PACs, SuperPACs, or other similar entities to finance litigation. Leagues [501(c)(3) and 501(c)(4) entities] may fundraise to underwrite litigation costs.

The League as Plaintiff

Plaintiff

- League directly challenges law/action
- Campaign for Making Democracy Work®

Standing

- The League's SUPERPOWER
- Individual | Membership | Diversion of Resources

Examples

- League of Women Voters of Fla v. Byrd
- Finn v. Cobb Cnty. Bd. of Elec. & Registration



The League as Intervenor

Intervenor

- Not Original Party
- Intervene to Represent Necessary Interest
- Seek Permission from Court
- Either Side

Examples

- Green v. Bell Voter Purges
 - North Carolina, Federal Court
- Ball v. Chapman Absentee Ballots
 - Pennsylvania, State Court



The League as Amicus

Amicus Curiae

- "Friend of the Court"
- Not a Party, But Strong Interest
- Must State Support
- Permission from All Parties or the Court
- Argument/Context Not Raised by Party's Brief

Example

- Merrill v. Milligan
 - Section 2 of the VRA
 & Redistricting
- Moore v. Harper

Communication Tools

- On **federal** matters/cases, LWVUS will lead communications in partnership with your League.
- On **state** matters/cases, messaging tools to use:
 - Press statements
 - Send to state/local press list and publish on your website
 - Must coordinate with LWVUS on any national press
 - Talking points & interviews
 - Top-level messages work with your legal counsel
 - Always highlight the impact on voters and impacted communities
 - Social media
 - Share your statement and any relevant articles
