

- Leagues may reach out prior to completing









Best Practice Alert!

In your electronic files (email, documents, etc.), take care not to delete anything that relates to advocacy work.


Create folders to keep it organized. These can be very general and broad.

When in doubt, **don't** throw it out.







WHO PAYS FOR LITIGATION 14








Best Practice Alert!

As the client, you are the keeper of your attorney-client privilege!

Take great care to protect any communications between you—meaning those in your League considered the client—and your attorneys.

This is especially important for written communications (emails, texts, chats, letters, etc.) **Do not forward, share, or include third parties on replies** unless you have explicit approval from your attorneys.





Best Practice Alert!

Do not use your personal email for official League business, especially if others have access to it (like family members).

Set up a League-specific email account just for League business.

Be careful who you share your email account information with to avoid breaking attorney-client privilege.







Attorney-Client Privilege **Legal Standing Requirement**



LEGAL STANDING REQUIREMENT 18

Establishing Standing <u>Has there been harm to the League or its members?</u>


Representational Standing

- a/k/a Membership or Associational Standing
- League sues on behalf of its members; members can also be plaintiffs
- May need to identify specifically harmed members

Direct Standing

- a/k/a Diversion of Resources or Organizational Standing
- Resources need not be financial
- Frustration of mission





Best Practice Alert!

Leagues can track volunteer hours by activity to demonstrate diversion of resources.

Documentation need not be incredibly detailed, but it should be kept as a regular part of the League's business and detail how much volunteer time has been spent on each activity or issue.





WHAT HAPPENS IN FEDERAL LITIGATION 22


Declarations

A declaration comes from the person or organization itself and is signed under penalty of perjury.

WHAT HAPPENS IN FEDERAL LITIGATION 24




Best Practice Alert!

During discovery, is best to provide all documents to your counsel that you find and let them determine which documents are responsive to discovery requests and for which requests to file objections.
