Congress Update

- Disagreements over Ukraine funding

Senate Republican Leader Position

- McConnell stepping down in November
 - Will remain in the Senate
- The "three Johns"- top contenders for replacements
 - John Cornyn of Texas
 - John Thune of South Dakota
 - John Barrasso of Wyoming



McConnell's Legacy

- Longest-serving member of the U.S. Senate
 - Began serving in the Senate in 1985
- Judicial nominations
 - Politicization of the judiciary
- Strategic policymaker



John Lewis Voting Rights Advancement Act

- Introduced in the House and Senate!
- Lobby Corps support
- LWVUS advocacy with offices on the Hill
- Historically the VRA had bipartisan support
 - Some Republican concerns emerging
