Talking Points/FAQs

- When we don't have official talking points on a subject, we will provide an FAQ page. It serves a similar purpose.
- Targeted questions and responses
- Intended for good faith challenges and reasonable questions

- For all League members
- Intended for local papers or media outlet of choice
- Customizable

Letter to the Editor Template

Restrictions on ballot assistance threaten the voting rights of many of our neighbors here in [State]. Lawmakers are considering [Bill Number or measure], a proposal that would limit who can help a voter cast a ballot. These restrictions would fall hardest on disabled voters, voters in long term care, people with limited English proficiency, and rural voters who rely on trusted helpers to participate in elections.

What these restrictions do accomplish is making it harder for disabled voters, voters in long term care, people with limited English proficiency, and rural voters to participate. Many of these voters rely on caregivers, interpreters, community members, or facility staff for help reading, marking, or returning a ballot. Limiting who may assist them creates real barriers to voting.

Voting is a fundamental right. Every eligible voter deserves a fair chance to cast a ballot with the assistance they need. For these reasons, the League of Women Voters of [State] urges legislators to reject [Bill Number or measure].

This template is designed for individual League members who are testifying in their personal capacity as members of their local or state League. Before submitting any testimony to your state legislature, virtually or in person, check with your League president or advocacy chair to ensure alignment with your state League's advocacy policies and procedures. Be sure to fill in the customization fields.

The result is less public input, fewer citizen-led initiatives reaching the ballot, and a system that favors the well-connected over everyday people.


