**4. Certificate of transcripts.** The defendant has ordered transcripts of the hearings and made arrangement with the court reporter.

**5. Appeal to the Arkansas Supreme Court.** The Arkansas Supreme Court has jurisdiction over the appeal under Arkansas Supreme Court Rule 1-2(b). The appeal involves the interpretation of the Arkansas Constitution. This appeal also involves issues of first impression, substantial public interest, and substantial questions of law.
